**OBJECTION TO CONFIRMATION**

**COMES NOW**, Susan H. Call, Counsel for Carl M. Bates the Chapter 13 Trustee, and moves this Court to deny confirmation of the Chapter 13 Plan filed on April 7, 2014, for the cause as follows:

1. The Debtor filed this Chapter 13 Petition on November 6, 2013 under 11 U.S.C. Chapter 13, now pending in the United States Bankruptcy Court, Eastern District of Virginia, Richmond Division.
2. This Objection is filed pursuant to 11 U.S.C. 1325.
3. The above filed Chapter 13 Plan fails to pay all the disposable income into the Chapter 13 plan shown by:
4. Upon belief and evidence, it appears that the above median debtors with excess income fail to list all of their income. They have income in the amount of \$495.00 for “Canadian Old Age Security” and an amount of \$337.00 for “Canadian Pension Plan” This is not income paid to the debtor under the Social Security Act (42 “USC Sections 301 et seq), so it does not qualify for exclusion. The Chapter 13 Trustee would suggest that the debtor pay all disposable income into the Chapter 13 Plan.

WHEREFORE, for the reasons stated herein, the Chapter 13 Trustee, by Counsel, Susan H. Call, respectfully moves the Court to deny confirmation of the Debtors’ proposed Chapter 13 Plan as filed with the Court, and for such further and other relief as in the premises may seem just.
